Dear Mrs. Tarango and Mrs. Trujillo:

This letter serves as the formal Notice of Unsatisfactory Performance for 21st Century Public Academy regarding the school's financial performance. Determination of the school's unsatisfactory performance results from the audit findings that are contained in the June 30, 2018, Audited Financial Statements.

Per Article 12 of the contract between Albuquerque Public Schools and 21st Century Public Academy, the authorizer shall issue a Formal Notice of Unsatisfactory Performance. In addition, the school is required to develop a Correction Action Plan (CAP), which addresses each of the audit findings outlined below. A sample CAP is enclosed.

21st Century Public Academy received 30 audit findings, including three for the Cutler Charitable Foundation. The findings include 1 significant deficiency and 13 material weakness classified findings. Below is a breakdown of the findings for FY18:

The Cutler Charitable Foundation, a component unit of 21st Century Public Academy, received the following findings for FY18:

Material Weakness Findings:

Another financial concern is the Liquidity ratio on the June 30, 2018 Audited Financial Statements. Based on the Charter School Fiscal Performance and Viability Report, when the Operational Unrestricted Fund Balance is below one-half month (0.5) of the average Operational Expenditures for the year this results in a "Needs Monitoring" rating. 21st Century Public Academy has a negative 0.2 months for FY18. A school should have more than 0.5 months of cash on hand.

A CAP was submitted to APS on October 29, 2018 that must be updated with current status and identify specific action steps and timeframe for each audit finding. The school shall present the CAP at a meeting on April 22, 2019 at 10:00 a.m. This meeting will be held at 6400 Uptown Blvd. NE in the East Tower on the 6th Floor. Check in with the superintendent's receptionist upon arrival. Please send the CAP electronically to Joseph Escobedo, Senior Director, Office of Innovation and School Choice at Escobedo J@aps.edu no later than April 12, 2019 by the close of business. This will allow the district to review the CAP prior to the meeting. The CAP must be approved by the district before monitoring will begin.

Because of the seriousness of this issue, the district requires that at least one member of the Governing Council be involved in all meetings regarding this issue until the district takes further action or the CAP is resolved.

The district will monitor the CAP until all matters are successfully resolved in specific deadlines or the district takes further action. As the authorizer of the school, the district will approve the CAP and then monitor the CAP. The district will offer assistance through the oversight of the CAP.
